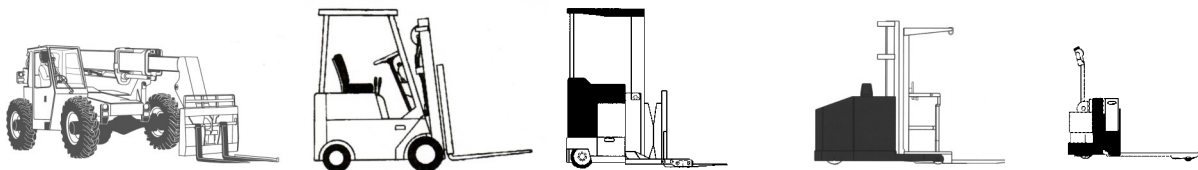
# Forklift Instructor Certification
